



Terms & Conditions Teknek Serial Number Competition

1. Introduction

These terms and conditions ("Terms") apply to the Teknek Serial Number Competition ("Competition") organized by Teknek ("Organiser"). By entering the Competition, participants ("Entrants") agree to be bound by these Terms.

2. Eligibility

- 2.1. The Competition is open to all Teknek customers who own and operate a Teknek machine.
- 2.2. Entrants must be at least 18 years old at the time of entry.
- 2.3. Employees of Teknek, its affiliates, subsidiaries, advertising and promotion agencies, and their immediate family members are not eligible to participate.

3. How to Enter

- 3.1. To enter the Competition, Entrants must:
 - a) Submit a photo of their operational Teknek machine.
 - b) Provide the machine's serial number.
- 3.2. Entries must be submitted via email: sncompetition@teknek.com or online submission form on the Teknek website.
- 3.3. Each Entrant may submit only one entry per Teknek machine owned.
- 3.4. Entrants may submit one entry for each operational Teknek machine owned.

4. Competition Rule

Random Draw

- 4.1. All qualifying entries will be entered into a random draw.
- 4.2. One first prize winner will be selected at random from all qualifying entries.
- 4.3. Five runner ups will then be selected at random from remaining qualifying entries.
- 4.4. The oldest qualifying entry will be awarded the "Oldest Machine Exclusive" prize.

5. Entry Period

- 5.1. The Competition entry period begins on 17th of June and ends on 16th Sept ("Entry Period").
- 5.2. Entries received after the Entry Period will not be considered.

6. Prizes

- 6.1. Prizes will be as follows:
 - a) First prize: A luxury weekend escape to the Scottish Highlands
 - b) Runner up prizes: Five Hampers with fine Scottish Produce.



c) Oldest Machine Exclusive: Scottish single malt whiskey & Tunnocks confectionary.
